#### **DESCRIPTION**

ArmaFloor® 400UVS – 12ltr kit is a two-component high gloss (2:1 mix ratio) 100% solids heavy duty epoxy clear finishing coat. For use as a clear coating system over various floor finishes in Industrial, commercial, or residential applications.

## NOT RECOMMENDED FOR

- ArmaFloor® 400UVS is not suitable for external use or other areas of high UV exposure
- Avoid working in conditions that could cause condensation to form on the uncured coating (for example high humidity or when the temperature is within 3°C to the dew point) as it can interfere with subsequent intercoat adhesion. If the surface is affected in this manner, it will require abrading prior to recoating.
- Do not apply to concrete less than 28 days old
- Do not apply to concrete with curing or sealing membranes
- Do not apply to base concrete less than 10°C and more than 35°C
- $\bullet\ \ \,$  Do not apply to substrates with a moisture content higher than 5%
- Should not be used where temperatures exceed 60°C
- Rhino ArmaFloor 400UVS should not be specified for external or indirect (not screened by glass) sunlight application, or other areas of high UV radiation exposure
- Avoid applying in conditions with high humidity
- **NOTE –** Substrate temperature **must** be 3°C above the dew point prior to application.
- Low temperature & high humidity can cause amine bloom. Contact Rhino Linings Technical Department.
- Tyre staining may occur on the finished coating due to different tyre chemical compounds.

Tack Free time 6 hours @ 25°C **Recoating Time** 16-24hours @ 25°C

**Application Temp** 10 - 35°C

The components should be mechanically mixed at a medium speed allowing for no air entrapment. The sides and bottom of the mixing container should be scraped during mixing. This product is mass dependent and quantities greater than 4 Litres should be mixed with care.

#### SURFACE PREP

See Rhino Linings® Application Standards for full surface preparation instructions. Substrate should be clean, dry and free of oils and other contaminants. Rhino™ recommends diamond grinding or shot blasting for creating a surface profile. Test for rising damp or back water pressure before application as adhesion failure is likely to occur if this is present. Old concrete floors previously contaminated with fats and oils should be tested for adhesion before application of epoxy compounds. Acid or wet etching is not recommended.

#### THICKNESS / COVERAGE

ARMAFLOOR® 400UVS is typically applied in two wet coats @100 to150 micron per coat with a total dry film thickness of approx 300 microns.

Coverage - Approx 6m2/L per coat

#### STORAGE & SHELF LIFE

ARMAFLOOR® 400UVS components should be stored in sealed containers in a dry area. Do not store product below 10°C. Unopened containers have a shelf life of 12 months at 25°C
